The petition coming on for hearing, upon perusing the Petition filed in support thereof and the earlier orders dated 21-11-2017 & 23-11-2017 made herein and upon hearing the arguments of Sri Praveen Kumar Veerjala, Advocate for the petitioner-accused and of the learned Additional Public Prosecutor (TG) for the Respondent-State, the Court made the following

ORDER:

“This petition is filed under Section 438 Cr.P.C. to grant anticipatory bail to the petitioner-accused for the offences alleged under Sections 406, 420, 409 and 506 IPC.

2. Heard learned counsel for the petitioner-accused, learned Additional Public Prosecutor representing the State and perused the record.

3. The dispute appears to be civil in nature.

4. Under these circumstances, the petitioner-accused is directed to surrender before the Judicial Magistrate of I Class concerned, within 15 days from today. On such surrender, the learned Magistrate shall release the petitioner-accused on bail on his executing a personal bond for Rs.10,000/- without sureties.

5. Personal appearance of the Station House Officer is dispensed with. The S.H.O. is directed to be very careful in future with regard to this kind of litigation.

6. Accordingly, the Criminal Petition is allowed.”
