Criminal Miscellaneous Application No. 26857 of 2017 has been filed for pre-poning the date of hearing of the appeal/application for leave to appeal (CRM-A-1274-MA of 2016) and for permission to withdraw the same.

Case FIR No. 88 dated 30.8.2015 was registered at Police Station Sudhar, Ludhiana, for the offences punishable under Sections 302, 307, 323, 324, 148, 149 of the Indian Penal Code ('IPC' for short), besides Sections 3 and 4 of the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989 ('SC & ST Act' for short). The said FIR was registered on the statement of the applicant/appellant-Inderjit Singh alias Jeggi Bains. Respondents No. 1 to 3 namely Karandeep Singh @ Bhachikar, Gurdev Singh and Sukhdarshpreet Singh @ Kamal, were tried by the learned Additional Sessions Judge, Ludhiana and were acquitted on 20.1.2016. The learned Additional Sessions Judge, observed that the complainant and the eye witness of the prosecution had not supported the

The applicant-Inderjit Singh alias Jeggi Bains aggrieved against the order acquitting respondents No. 1 to 3, filed CRM No.A-1274-MA of 2016, seeking leave to appeal. The said case was taken up on 19.8.2016, 22.2.2017 and 17.5.2017. It now stands listed for 30.11.2017. However, as already noticed, the applicant seeks preponement of the date of hearing and for withdrawing the appeal/application seeking leave to appeal. The application for preponing and withdrawing the appeal/application for leave to appeal, is supported by an affidavit of the applicant.

In the circumstance, CRM No. 26857 of 2017 is allowed and date of hearing is preponed for today and CRM No.A-1274-MA of 2016 is dismissed as withdrawn.
