Learned counsel for the petitioners states that petitioner No.1 is major and residing with the family of petitioner No.2 with her own sweet free will. They have solemnized marriage. He cites 'Neelam Rani and another Vs. State of Haryana and others', 2011 (1) RCR (Civil) 636, to contend that the petitioner No.2 has reached the age of discretion. Their marriage is opposed by respondent Nos.4 to 7.

At the asking of the Court, Mr. Saurabh Mohunta, DAG, Haryana accepts notice on behalf of the respondent-State. A complete copy of the paper book has been furnished to the learned counsel, in the Court.

27.04.2017 (Annexure P-5) moved by the petitioners and provide necessary protection to the petitioners in accordance with law in case he is satisfied that the life and liberty of the petitioners is threatened at the hands of respondent Nos. 4 to 7.
