Learned counsel for the petitioners states that petitioner No.1 is major and residing with the family of petitioner No.2 with her own sweet free will. They have solemnized marriage. He cites '**Neelam Rani and another Vs. State of Haryana and others**', 2011 (1) RCR (Civil) 636, to contend that the petitioner No.2 has reached the age of discretion. Their marriage is opposed by respondent Nos.4 to 6.
