Learned counsel for the petitioners states that though petitioner No.1 is minor but she is residing with the family of petitioner No.2 with her own sweet free will. They have solemnized marriage. He cites '**Neelam Rani and another Vs. State of Haryana and others**', 2011 (1) RCR (Civil) 636, to contend that the petitioner No.1 has reached the age of discretion. Their marriage is opposed by respondent Nos.3 to 6.

Notice of motion.

At the asking of the Court, Ms. Gautam Dutt, Addl.PP, U.T.,Chandigarh accepts notice on behalf of the respondent-State. A complete copy of the paper book has been furnished to the learned counsel, in the Court.

Without expressing any opinion with regard to validity of marriage and on the merits of the assertions made in the petition, the instant petition is disposed of with the direction to respondent No.1- Senior

Superintendent of Police, Chandigarh, U.T.Chandigarh to take necessary action on the representation dated 28.04.2017 (Annexure P-4) moved by the petitioners and provide necessary protection to the petitioners in accordance with law in case he is satisfied that the life and liberty of the petitioners is threatened at the hands of respondent Nos. 3 to 6.
