Prayer in the instant petition under Section 482 Cr.P.C. has been made for quashing of the Cross Version which was registered vide DDR No. 35 dated 05.05.2017 under Section 452, 506, 148, 149 IPC and Sections 323 and 324 IPC added subsequently at Police Station Jandiala, Distt. Amritsar Rural in FIR No.83 dated 04.05.2017 under Sections 452, 323, 324, 148, 149 IPC and Section 326 and 325 IPC registered at Police Station Jandiala, District Amritsar, on the basis of compromise dated 22.05.2017 (Annexure P-3).

Pursuant to the order dated 28.09.2017 of this Court, the parties appeared before the trial Court on 24.10.2017 to get their statements recorded. Learned Judicial Magistrate Ist Class, Amritsar, has submitted his report vide letter bearing No.119 dated 24.10.2017 duly forwarded by

According to the report, the learned Judicial Magistrate Ist Class is satisfied that compromise entered into between the parties is genuine, voluntary, and without any inducement, threat or pressure. None of the accused has been declared proclaimed offender in this case.

Considering the report of learned Judicial Magistrate Ist Class dated 24.10.2017 and the fact that the compromise will bring harmony in relations between the parties, Cross Version which was registered vide DDR No. 35 dated 05.05.2017 under Section 452, 506, 148, 149 IPC and Sections 323, 324 IPC added subsequently at Police Station Jandiala, Distt. Amritsar Rural in FIR No.83 dated 04.05.2017 under Sections 452, 323, 324, 148, 149 IPC and Sections 326 and 325 IPC registered at Police Station Jandiala, District Amritsar, is hereby quashed.

Petition is disposed of accordingly.
