In FIR No.275 dated 14.11.2014 registered under Sections 3, 4, 4-A and 3/67 Public Gambling Act, 1867 and Sections 418, 420, 464, 468, 470, 471 and 120-B of Indian Penal Code, 1860 at Police Station NIT, Faridabad, the petitioner is being prosecuted. From the submission made by the learned counsel for the petitioner, it is clear that number of facts are involved and at any rate the entire challan will have to be looked into. The best course for the petitioner is to oppose the framing of charge and thereby get himself discharged, if the petitioner is right in what he has contending. In that view of the matter, the petitioner having the remedy of opposing the framing the charge against him, the present petition is disposed of with a direction to the trial Court to hear the petitioner on the question of framing of the charge within three months from today.

All contentions that may be raised by the learned counsel for the parties are kept open.
