Present petition has been filed under Section 482 Cr.P.C. for quashing of FIR No.16 dated 07.02.2013, under Sections 498-A, 323, 506 and 34 IPC, registered at Police Station Ahmedgarh, District Sangrur, on the basis of compromise/affidavit dated 02.11.2015 (Annexure P-3).

Brief facts of the case are that marriage between son of the petitioner Sha Niwaj and respondent No.2 was solemnized in the year 2011. After the marriage, the behavior of accused changed and they have started giving beatings to the complainant. Due to incompatibility of temperament, the relationship between them became strained and thereafter, the F.I.R was registered against the petitioner.

Learned counsel for the petitioner submits that keeping in view the peace and harmony, the matter has now been amicably settled between the parties with the intervention of respectable persons, vide compromise/affidavit dated 02.11.2015 (Annexure P-3).

During the course of preliminary hearing, the trial Court, was directed to record the statements of all the concerned parties, with regard to the genuineness and validity or otherwise of the compromise/affidavit dated 02.11.2015 (Annexure P-3), by way of order dated 02.09.2016, by this Court.

In compliance of order dated 02.09.2016 of this Court, the report of the Judicial Magistrate 1st Class, Malerkotla dated 14.02.2017 has been received. As per the report, the statements of all the concerned parties have been recorded and the complainant has no objection, if the present FIR registered against the petitioner is quashed. Statements of the petitioner and complainant have been recorded to the same effect.

Consequently, in view of the above-said report and in view of the judgments of the Hon'ble Supreme Court in **Dr. Arvind Barsaul etc. Vs. State of Madhya Pradesh and another**, 2008(2) RCR (Criminal) 910; **Madan Mohan Abbot Vs. State of Punjab**, 2008(2) RCR (Criminal) 429 and the law laid down by the Full Bench of this Court in the case of **Kulwinder Singh and Ors. vs. State of Punjab and another**, 2007(3) RCR (Crl.) 1052, no useful purpose would be served in prolonging the litigation.

Accordingly, FIR No.16 dated 07.02.2013, under Sections 498-A, 323, 506 and 34 IPC, registered at Police Station Ahmedgarh, District Sangrur and all the subsequent proceedings arising therefrom are hereby quashed qua petitioner only, on the basis of compromise/affidavit dated 02.11.2015 (Annexure P-3).

The present petition stands disposed of.
