By filing the present petition, under Section 439 of the Code of Criminal Procedure, the petitioner has sought regular bail in FIR No. 54 dated 07.05.2016, registered under Sections 302, 120-B read with Section 34 of IPC and Section 25 of Arms Act, at Police Station Linepaar Bahadurgarh, District Jhajjar.

It is contended that it is a case of version and cross version wherein both the parties have not supported their version. All the material witnesses have been examined.

On the other hand, learned State counsel opposes the bail application.

I have heard learned counsel for the parties and perused the record.

Considering the fact that all the material witnesses stand

examined; the chances of any coercion, threat or interfering in the process of the Court at this stage appears to be remote, without advertng to the merits of the instant case, this petition is allowed. The petitioners be admitted to bail during the pendency of trial, on their furnishing bail bonds and surety bonds to the satisfaction of the trial Court.
