Through this petition under Section 439 Cr.P.C., prayer has been made for grant of regular bail to the petitioner in case F.I.R. No.220 dated 23.07.2016 registered under Section 21C/61/85 of the Narcotic Drugs and Psychotropic Substances Act, at Police Station City Mandi Dabwali, District Sirsa.

According to the prosecution, on secret information, 23 bottles of corex weighing 100 ml each were recovered from car No.HR-24L-7738 occupied by four persons including the petitioner.

Learned counsel inter-alia contends that co-accused of the petitioner, namely, Harpreet Singh @ Gori and Devender Pal have been granted regular bail by this Court vide order dated 13.07.2017 passed in CRM-M-23482-2017 and dated 20.11.2017 passed in CRM-M-38317-2017.

The petitioner is in custody since 23.07.2016 and no other case is pending against him.

On the other hand, learned State counsel vehemently opposed the bail to the petitioner.

Considering over all facts and circumstances, but without commenting anything on the merits of the case and treating the case of the petitioner on the same parity as that of his co-accused, the petition is allowed and the petitioner is granted regular bail, during the trial, subject to his furnishing bail bond and surety bond to the satisfaction of the trial Court.
