The State of Haryana and others.**

On a specific query, learned counsel have submitted that the case of none of the petitioners has been rejected for any reason by the respondent-State.

In view of above, all these petitions are disposed of with a direction to the appropriate authorities to take a decision in each case of the petitioners, on merits, in terms of the judgment in Neelam Ranis' case

(supra), which has attained finality up to the Supreme Court, within a period of five months from the date of receipt of a certified copy of this order.

As all these cases are being disposed of en masse, liberty is given to the State to point out anything specific in individual cases, if there is some specific issue.
