2012 in Vice Chancellor, Kurukshetra vs. Raj Rani & another and 16
connected writ petitions, decided on 16.10.2015, against which Letters
Patent Appeal and the Special Leave Petition filed before the Supreme
Court have been dismissed.

Accordingly, the writ petitions filed by the University are
dismissed and the petitions filed by workmen are disposed of in terms of
Raj Rani's case (Supra).
