FATEH DEEP SINGH, J. (ORAL)

In compliance of the orders dated 28.02.2017 of this Court,
Mr. Harjit Singh, SSP Tarn Taran and Inspector Kanwarpreet Singh,
SHO, Police Station City, Tarn Taran have come present.

It has been brought to the notice of this Court by the SSP that
the orders of this Court dated 21.02.2017 were never communicated to
them which could not be displaced by learned State counsel. In the light
of this insolence shown by the Advocate General office and the fact that
it is not the first instance that such a thing has happened as this Court has
even on earlier occasions observed it so, impels this Court to deprecate
conduct of the office of Advocate General in unnecessarily putting to
harassment senior functionaries of the police department. The officers are
discharged from their personal appearance before this Court.

Gurleen Kaur, the alleged detainee has come present under the escort of lady police official SI Amanjot Kaur and has been identified by her mother, the present petitioner Balwinder Kaur who is also present as well as her counsel Mr. Kawaljyot Singh, Advocate. The girl has made statement before this Court that though she has undergone marriage with Jaspreet Singh who is also present in Court but is not a party to this petition, however she does not want to accompany him and wants to live with her parents and has shown her wishes to go with her mother the present petitioner Balwinder Kaur.

In the light of the same, being a major the detainee Gurleen Kaur is well within her rights to go as per her wishes and to lead her life. The girl has accompanied her mother present petitioner Balwinder Kaur from the Court. Police is directed to ensure due protection till the place of her abode.

Learned counsel for the petitioner on account of this stand of the girl has made statement withdrawing the present petition, the same having been rendered infructuous.

Allowed to do so.

The petition stands dismissed as withdrawn.
