By virtue of instant civil writ petition preferred under Article 226/227 of the Constitution of India, the petitioner has sought issuance of a writ in the nature of Mandamus directing the respondents to release balance amount of gratuity and leave encashment along with other benefits to the petitioner.

2. The contention of learned counsel for the petitioner is that the petitioner was appointed as Safai Sewak in the office of respondent No.4 and she was retired from service on 30.04.2011 after attaining the age of 60 years but till today a period of more than 6 years have been elapsed, the retiral benefits have not been released to the petitioner by the respondents so far, despite having been served through legal notice dated 23.03.2017 (Annexure P-2).

3. The instant petition is disposed of with the direction to respondent No.4-Executive Officer, Municipal Council, Tapa, Barnala to look into the grievances unfolded by the petitioner in her legal notice dated 23.03.2017 and

take an appropriate decision within a period of 45 days from the date of receipt of certified copy of this order and in case of non-disposal of the matter within the stipulated period, it would entail disciplinary action.
