Main Cases

This order will dispose of TA No.471, CRM-M-33084 and 33087 of 2017 as identical questions of law and fact are involved for adjudication. For brevity, facts are taken from TA No.471 of 2017.

Counsel for the parties are *ad idem* that all the three cases namely Petition No.448 of 2016 titled **Puran Parkash Gogna Vs. Neetika Rani** filed under Section 13 of the Hindu Marriage Act, 1955 (in short 'the HMA') by the husband, application No.346 of 2016 titled **Neetika Rani and another Vs. Puran Parkash Gogna** under Section 125 of the Code of Criminal Procedure and petition bearing No.278 of 2016 titled **Neetika Rani Vs. Puran Parkash and others** under Section 12 of the Protection of Women from Domestic Violence Act, 2005 may be transferred to a Court of competent jurisdiction at SAS Nagar, Mohali.

In view of the above, the aforesaid cases are withdrawn from the Court(s) at Chandigarh and petition under Section 13 of the HMA is transferred to the Court of District Judge, SAS Nagar, Mohali and other two cases are transferred to the Court of Chief Judicial Magistrate, SAS Nagar,

Mohali for proceeding with the cases in accordance with law.
