Petitioner is the Management, who is aggrieved by Award of 25th September, 2013 vide which it has been directed that respondent-workman be reinstated with 50% back wages.

As per order of 17th December, 2015, efforts for reconciliation have failed and the case was adjourned to 25th April, 2016 to be heard on merits. After 17th December, 2015, none has been appearing on behalf of petitioner in spite of the fact that these cases have been taken up for hearing on three earlier occasions.

Even today in pre-lunch session, none had appeared on behalf of petitioner and the matters were passed over for post-lunch session. Now, these matters are taken up in post-lunch session. Still, none appears on

behalf of petitioner. In such a situation, there is no option except to dismiss these petitions in default.

In view of above, these petitions are dismissed in default. Consequently, the pending applications are disposed of as infructuous. Respondents are at liberty to get the impugned Award executed.

The application is allowed and the matter is taken for early hearing today itself. The date of 08th July, 2019 is cancelled.

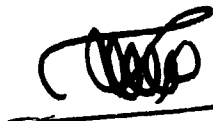
CM No.19842/2019
