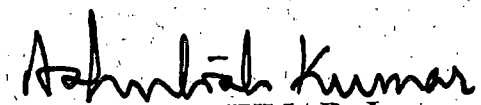

The status report with regard to the *piao* at Sis Ganj Gurudwara dated 04.02.2017 is taken on record. The Consultants have inspected the site and have indicated that the *piao* has been constructed as per the proposal which had been submitted by the Gurudwara Committee except for a slight deviation in the design of the serving counter which does not affect the pedestrian movement.

In view of the foregoing, no further directions are necessary in the writ petitions. Hereafter, the earlier orders restricting the use of the *piao* stand vacated. Consequently, there is also no need for any special police force for being deployed there.

The writ petitions stand disposed of.
