Having heard the learned counsel appearing on behalf of the parties and perused the evidence on record, in particular, the testimony of PW7; the prosecutrix; as well as PW1, the Doctor, who certified the status of PW7 to the effect that she was a minor on the date of the commission of the offence,

we are of the view that the present is a good case for grant of leave to appeal.

The leave petition is accordingly allowed and disposed off.
