1. The petitioner in compliance of the order dated 11.01.2017 has given ₹8 lacs to the complainant's counsel.

Complainant is not present in the Court today. ₹50,000/- have been handed over to her counsel Ms.Usha Mann, Advocate. Her statement to this effect has been recorded. She shall hand over ₹50,000/- to the complainant.

7. After accepting the apology tendered by the petitioner and withdrawal of the allegations levelled in the application, no further action is required and the application stands disposed of in the above terms.
