1. The present transfer petition has been filed by the petitioner praying for transfer of Civil Suit No.273/2015 titled as '*Anil Gupta vs. Shashi Bansal*' pending in the Court of Mr.Prashant Kumar, ADJ, North-West District, Rohini Court, Delhi to the Court of Ms.Manjusha Wadhwa, ADJ-04, West District, Tis Hazari Court, Delhi where Civil Suit No.11753/2016 titled as '*Jai Prakash Verma vs. Shashi Bansal*' filed by respondent No.2 herein is pending.

2. Notice of the petition was issued to the respondents.

3. Learned counsel for the petitioner submits that the subject matter of Civil Suit No.273/2015 i.e. the suit property falls with the jurisdiction of West District, hence Civil Suit No.273/2015 may be transferred to the Court
