5. I have enquired from the counsel for the petitioner as to why the decree in terms of settlement in mediation cannot be passed in the suit pending in this Court and the suits sought to be transferred disposed of in terms thereof.

6. The counsel for the petitioner states that the counsel for the respondent/s, in mediation, insisted on the transfer.

7. Believing the counsel for the petitioner, the petitions are allowed.

Harpal Singh & Anr*** pending in the Court of Sh. Sunil Chaudhary, Additional District Judge (North-West), Rohini Courts, Delhi are, in exercise of powers under Section 24 of the Code of Civil Procedure, 1908, transferred to this Court to be taken up along with CS(OS) No.2098/2015 titled ***Harpal Singh Vs. Harmeet Singh & Ors*** of this Court.

9. The Transferor Courts to forthwith physically transfer the files.
10. The parties to appear before this Court in the transferred suits on 17th November, 2017, when CS(OS) No.2098/2015 of this Court is stated to be listed.
11. The petitions are disposed of.
