2 16-05-2018 The learned counsel for the petitioners has submitted that on account of mistake in depicting the name of the respondent no. 4 in the writ petition, the nomenclature of respondent no.4 has been recorded in the order dated 27.03.2018 as Principal Secretary, Department of Minor Agriculture Department, Govt. of Bihar, Patna instead of Principal Secretary, Department of Minor Irrigation, Govt. of Bihar, Patna.
