Keeping in view the fact that the question of transfer of ownership of the vehicle in question is pending before the District Transport Officer, Muzaffarpur, for the present, without entering into the controversy on merit, respondent No.4, the District Transport Officer, is directed to pass an appropriate order for transfer of the vehicle in accordance with law within a period



of 15 days from the date of receipt/production of a copy of this order. However, the transfer in pursuance to the aforesaid order shall be subject to the petitioner complying with all statutory requirement in accordance with law. The Customs Department, from whom the petitioner has purchased the vehicle, should cooperate in submitting the documents before the statutory authority for passing an appropriate order with regard to transfer of ownership.

With the aforesaid, this application is disposed of.
