Learned counsel appearing on behalf of the petitioners submits that the case of the petitioners is covered by the decision of this Court dated 31.03.2011 in CWJC No. 6139 of 2007 which was affirmed by order dated 16.8.2017 in LPA No. 756 of 2015. Relying on the said decision a Co-ordinate Bench of this Court in CWJC No. 14670 of 2014 has disposed of the writ petition with the direction to extend similar treatment to the petitioners of that case. Similar view was expressed by this court earlier in numerous cases.

In view of the above, these writ applications are disposed of with a direction to the respondents to consider the case of the petitioners of these cases and extend similar benefits to them within a period of sixty days from the date of receipt/production of a copy of this order.
