The present writ petition has been filed for quashing disqualification letters at Annexures-3 and 8 by which the tender of the petitioner for construction of godown at Jehanabad has been discriminately declared disqualified



whereas the tender of the private respondent no. 8 who has also participated for Tender No. ED07/2012-13 for construction of godown under Bihar Agriculture Road Map for the location Jehanabad, Bihar Sharif and Sasaram has been accepted; and for connected reliefs.

2. Learned counsel for the petitioner submits that the matter has become infructuous by efflux of time and the writ petition need not be pressed.

3. The writ petition accordingly stands dismissed.
