2 15-03-2018 This application under Section 482 of the Code of Criminal Procedure has been filed by the petitioners for quashing the order dated 04.08.2015 passed by the learned Sub-Divisional Judicial Magistrate, Siwan in Trial No. 3423 of 2017 arising out of Siwan (Muffasil) P.S.Case No. 435 of 2014 whereby cognizance has been taken against them for the offences punishable under Sections 498-A, 323 and 406 of the Indian Penal Code and Section



3 and 4 of the Dowry Prohibition Act.
