It is submitted by the learned counsel for the review petitioners that the issue decided in the L.P.A. under review is pending consideration in some other proceedings. He apprehends that he would be deprived of the fruits of adjudication in the



pending proceeding, if the issues of law are decided and are favourable to him, keeping in view the order passed in the L.P.A. under review.

2. The submissions advanced by counsel for the review petitioners on the basis of apprehensions do not make out any ground for review.

3. This Court would only observe that if any declaration of law is made in respect of the claim made by the petitioners, in the other pending proceeding, it would be open for the petitioners to take appropriate remedy, in accordance with law.

4. The application stands dismissed.
