The issues involved in the present writ application is squarely covered by this Court's decision dated 24.08.2017 rendered in C.W.J.C. No. 1366 of 2017 (*Uchatar Madhyamik School (+2) Vs. The State of Bihar and others*) and other analogous matter, which also came to be affirmed by a Division Bench of this Court in L.P.A. No. 1431 of 2017 (*Bihar School Examination Board and Others vs. Asha Sinha Memorial Uchcha Madhyamik Vidyalaya and others*) and other analogous matters disposed of on 13.07.2018.

In above view of the matter, this writ application also stands disposed of in the same terms and directions as passed in *Uchatar Madhyamik School (+2) Vs. The State of Bihar and others* (supra).
