Heard learned counsel for the petitioners and learned counsel for the State.

Learned counsel for the petitioners submits that the facts of the present case are identical to the case of C.W.J.C. No. 20654 of 2010 (Raj Narayan & Ors. Vs. The State of Bihar & Ors.) and C.W.J.C. No. 10901 of 2006 (Md. Kayumuddin Ansari & Ors. Vs. The State of Bihar & Ors.), the aforesaid judgment/orders squarely cover the issue involved in the present case.

In such view of the matter, the concerned authority is directed to examine the facts, law and prayer of the case of petitioners and if it is found that present case is squarely covered by the aforesaid cases, the same benefit should also be extended to the petitioners.



Whole the process should be completed within a period of four months from the date of receipt/production of a copy of this order.

With the aforesaid observations and directions, this writ petition is disposed of.
