Keeping in view the fact that the issue involved is sub judice before the Hon'ble Supreme Court in Civil Appeal No.13301 of 2015 wherein writ petitions of identical nature pending not only from the Jharkhand High Court, as is evident from the order of the Jharkhand High Court available from page 220 onwards, but from other High Courts also have been ordered to be transferred to the Supreme Court, we are not inclined to make indulgence into the matter.
