Seeking exception to an order dated 15.03.2016 passed by the learned Writ Court in CWJC No. 11408 of 2015 this appeal has been filed under Clause 10 of the Letters Patent.

Having heard learned counsel for the parties, we are of the considered view that in the matter of constitution of a Managing Committee of the institute in question in case the appellant has any



grievance, she may file the appeal before the statutory authority notified for the District level /State Level by the State Government as per Regulation 22 and sub-Regulation 22(1) before the Statutory Tribunal which is said to be functioning under the Chairmanship of a retired Judge of this Court or else may take recourse the remedy of filing a civil suit in the matter of constitution of the Committee.

Granting the aforesaid liberty, the appeal stands disposed of.
