Keeping in view the fact that the grievance in this Public Interest Litigation petition is with regard to removal of encroachment made by respondent No. 8 in the village in question, for the present, without entering into the controversy on merit, it is directed that the petitioner shall file a certified copy of this order along with a detailed representation seeking removal of



encroachment before respondent No. 7 and respondent No. 7 shall register the same as an encroachment case under the Bihar Public Land Encroachment Act, issue notice to all concerned, hear them and after following the principles of law remove the encroachment in accordance with law, preferably within six months from the date of presentation of the representation.

With the aforesaid, this application stands disposed of.
