Heard both sides.

The petitioners have filed this writ petition for a direction to the respondent no. 2, the District Magistrate, Saharsa to dispose of Bandobasti Appeal No. 10 of 2013 which have been filed by the petitioners for cancellation of settlement made by DCLR Saharsa in favour of private respondent.



The learned counsel for the petitioners submits that the State has filed counter affidavit but did not state about the disposal of Bandobasti Appeal No. 10 of 2013 pending before the Collector.
