In the present writ application, the following relief has
been sought for on behalf of the petitioner :

(1) That this writ application is being filed for
issuance of an appropriate writ/writs and
order/orders in the nature of mandamus for directing
and commanding the respondents to pay the arrear of
salary as difference of arrear of revised pay scale in
Feb, 1988 to Feb, 2013, total amounting of



Rs.21,84,348/- (Twenty one lac eighty four thousand three hundred and forty eight) with 12% interest and further for any other relief/reliefs for which the petitioner is entitled from the facts and circumstances of this case.

It has been submitted on behalf of the petitioner that the case of the petitioner is squarely covered by the order dated 05.12.2017 passed in C.W.J.C. No.4573 of 2017. Said order is Annexure-3 to the present application.
