(xiii) At page 8 of the order dated 17.07.2018 passed in C.W.J.C. No. 10806 of 2018 in all places let 'petitioners' be read in place of 'petitioner'.

The order dated 17.07.2018 passed in C.W.J.C. No. 10806 of 2018 is modified to the extent as indicated above.

The modification application is, accordingly, allowed.
