ORAL ORDER

3 12-02-2018 Heard learned counsel for the petitioner and the State.

The petitioner apprehends his arrest in

Khodabandpur P.S. Case No. 105 of 2017 instituted for the
offence under Sections 467, 468, 471, 420 and 120(B)/34 of the
Indian Penal Code.

Learned counsel for the petitioner has submitted that
the instant case has been registered on the basis of observation of
this Hon'ble High Court passed in CWJC No. 15459 of 2014. The
enquiry was set up by the Vigilance department to enquire about
the Academic certificates of the teachers appointed since 2006 to
2015. During enquiry, various certificates including the
Matriculation certificates of teachers appointed as mentioned in
the First Information Report were found forged. It has further been



submitted that co-accused Rinku Kumar @ Rinku Kumari with similar allegation has already been granted anticipatory bail by a coordinate Bench of this Court vide order dated 10.01.2018 passed in Cr. Misc. 58671 of 2017.

The allegation against this petitioner is that during enquiry of Bihar School Examination Board certificates, there was some discrepancy found in Serial Number of the certificate. It is mentioned in the First Information Report itself at page 11 that all the columns filled up by the candidate was found to be correct and he was also found to be qualified.

Considering the facts and circumstances of the case, prayer for anticipatory bail of the petitioner is allowed. In the event of surrender/arrest of the petitioner, named above, within six weeks from today, in connection with **Khodabandpur P.S. Case No. 105 of 2017**, he shall be released on anticipatory bail on furnishing bail bond of Rs.10,000/- (Ten thousand) with two sureties of the like amount each to the satisfaction of **learned Sub Divisional Judicial Magistrate, Manjhaul, Begusarai**, subject to the conditions as laid down under Section 438 (2) Cr. P.C. with further conditions (1) bailors should be local having sufficient immovable property within the jurisdiction of the court concerned, (2) petitioner shall cooperate in the trial and shall be



present on each and every date fixed by the court and their absence on two consecutive dates without proper and reasonable reason will be liable to cancel his bail bond and (3) if petitioner tampers with the evidence or the witnesses of the case, in that case, prosecution will be at liberty to move for cancellation of bail of the petitioner.
