Likewise, the name of petitioner no. 4 and her husband be read as 'Reema Devi @ Reema Kumari, wife of Shri Rakesh Prasad' in place of 'Reema Devi @ Munni @ Laxmi Gupta, W/o Shri Rajeev Prasad, All are R/o Mohalla-Bari Patan Devi Colony, near Community Hall, P.S. Alamganj, District- Patna.' Similarly at page 2 of the said order dated 04.01.2018 in



11th line be read as ‘petitioners are’ in place of ‘petitioner is’ and in 13th line, be read as ‘petitioners’ in place of ‘petitioner’.

Furthermore, the petitioners are granted six weeks’ time to surrender and furnish bail bond in the court below from today.
