2 18-07-2018 This miscellaneous application has been filed for modification of the order dated 13.01.2017 passed in C.W.J.C.No.621 of 2016 to the extent of the Notification number mentioned in paragraph 2 at page 1 of the judgment which reads 'Notification No. CF.-17625, 67-2113-R dated 22.7.1967'.
