3. Petitioner is the applicant for allotment of PDS dealership for Village Panchayat Jalwara, Keoti Block in the District of Darbhanga. The District Selection Committee, Darbhanga made a panel of three PDS dealers vide its meeting dated 05.08.2017 in which the name of petitioner does not find place.



4. Counsel for the petitioner submits that against her non-empanelment petitioner has represented before the Sub-Divisional Officer, Sadar, Darbhanga vide her letter dated 11.08.2017 (Annexure-5), but the same has not yet been considered.

This writ application is disposed off with a direction to the Sub-Divisional Officer, Sadar, Darbhanga (Respondent No. 4) to consider the representation of the petitioner and pass appropriate order in accordance with law within a period of six weeks from the date of receipt/production of a copy of this order.
