3 11-04-2019 This case has been listed under the heading “To Be Mentioned” at the instance of this Court for modification in the order dated 03.12.2018.

It appears that, on 03.12.2018, this record was placed before this Bench (Justice Rajendra Kumar Mishra) under the heading “For Admission” and after hearing, the petitioner nos. 1 and 2, namely, Gulsan Kumar and Promod Kumar were granted privilege of bail on furnishing bail bonds of Rs.10,000/- (Rupees Ten Thousand) each with two sureties of the like amount each to the satisfaction of Additional Sessions Judge-II-cum-Special Jude, Excise Act, Saharsa, in connection with Special (Excise) Case No. 448 of 2018 arising out of Basnahi P.S. Case No. 92 of 2018 and the prayer for bail of petitioner no.
