2 12-07-2018 Heard learned counsel for the petitioner and learned
counsel for the State.

The present application has been filed for
modification of the order dated 24.04.2018 passed in
Cr.Misc.No. 24127 of 2018, by which the petitioner was granted
anticipatory bail and the petitioner was directed to surrender and
furnish bail bond in the court below within a period of six
weeks.

It is submitted on behalf of the counsel for the
petitioner that due to some unavoidable reasons the petitioner
could not surrender and furnish bail bond in the court below
well within time. It is further prayed on behalf of the counsel for
the petitioner that further time may be extended so that the



petitioner could surrender and furnish bail bond in the court below.

It is further submitted on behalf of the petitioner that due to inadvertence in the order dated 24.04.2018 passed in Cr.Misc.No.24127 of 2018, P.S. case has wrongly been typed as “Magadh University P.S. case No.184 of 2017” in place of “Magadh Medical P.S. case No.184 of 2017”.

Let in the order dated 24.04.2018 passed in Cr.Misc.No.24127 of 2018. “Magadh Medical P.S. case No.184 of 2017” be read in place of “Magadh University P.S. case No.184 of 2017”.

Considering the submissions made on behalf of the learned counsel for the petitioner and the grounds mentioned in the modification application, the period of surrender of the petitioner in the court below is extended for a further period of six weeks from the date of receipt/production of a copy of this order. The rest of the conditions stipulated in the order well be same.

The order dated 24.04.2018 passed in Cr.Misc.No. 24127 of 2018, is modified to the extent as indicated above.

The modification application is, accordingly, disposed of.
