a common order passed in L.P.A. No.535 of 2017 the Co-ordinate Bench has dismissed all identical appeals on17.4.2018.

Keeping in view the aforesaid order passed on 17.4.2018 in L.P.A. No.535 of 2017, we see no reason to make any indulgence into the matter. For the same grounds and reasons as are indicated in the said order, this appeal also stands dismissed.
