At the outset, it is brought to the notice of the Court that though this writ petition was filed challenging special meeting for discussion on want of confidence in the Pramukh of Panchayat Samiti, Obra Block, during pendency of the writ petition, the special meeting was convened and no confidence motion was carried out against the petitioner.
