Counsel for the petitioners submits that in light of the decision in the case of Subhash Mohan Mishra & Ors. vs. the State of Bihar & Ors., decided in a proceeding arising out of C.W.J.C. No. 14088 of 2012 and LPA No. 1109 of 2013 the petitioners' claim for getting the benefit of promotion as Headmaster by considering their degree to be equivalent to a post graduate degree and holding the petitioners qualified for the said promotion is pending before the District Programme Officer (Establishment), Gaya since 24.08.2016. The limited
