ORAL ORDER

5 17-07-2018 Mr. Yugal Kishore, learned Senior Counsel appearing on behalf of the petitioners states that the petitioners will be applying afresh to the Bihar School Examination Board for grant of affiliation within one month from today. If such application is made, the Court expects that the Board shall



consider the same strictly, in accordance with law and take a final decision within four months from the date of such application.

Mr. Yugal Kishore, learned Senior counsel states that the petitioners have submitted the affiliation fee earlier, which should be adjusted for the purpose of the application, which the petitioners will be filing afresh.

It will be open to the Affiliation Committee of the Board to consider the petitioners' requests in this regard and if found to be permissible, such fee may be adjusted against the application to be filed afresh.
