The learned counsel for the petitioner submits that petitioner is the appellant of Title Appeal No.12 of 1997. The appeal was heard by Additional District Judge III on 21.04.2012 and the appeal was posted for argument of the respondent-plaintiff but since then the appeal is pending.
