3 10-08-2018 It appears that the parties are litigating over a piece of land related to Title Suit No. 455 of 2006 and the allegation of the petitioners was that the private respondent nos. 6 and 7 were trying to take possession of the land of the petitioners. Based on this statement, a prayer has been made to direct the respondent authorities to protect the life and property of the petitioner.
