Officer (Estt.), Saran, the Regional Dy. Director of Education, Saran was asked to be present in Court. He has admitted that he has no direct concern with the implementation of the order in question. However, he has to be cautious in exercising his jurisdiction.

Considering the totality of the fact situation, the present contempt proceeding is dropped. Personal appearance of the Regional Dy. Director of Education, Saran is dispensed with.
