In case there is encroachment in the area in question and the same is not being removed, petitioner may file a complaint in this regard along with details of the encroachment impleading the encroachers as a party before respondent No.8 along with a



certified copy of this order. On the same being done, respondent No.8 shall register the same as an encroachment case under the Bihar Public Land Encroachment Act and after following the due process of law, hearing all the concerned persons, shall pass appropriate orders for removal of encroachment, preferably within six months.

With the aforesaid, this application stands disposed of.
