Counsel for petitioners submits that grievance of the petitioners is covered by the decision of this court as contained in Annexures-4, 8 & 9 i.e. order dated 31-03-2011 passed in CWJC No. 6139 of 2007, Judgment dated 16-08-2017 passed in LPA No. 756 of 2015 and order dated 01-11-2017 passed in CWJC No. 14670 of 2014.

In view of the above, this writ application is disposed of with direction to the respondent No. 7 District Programme Officer (Establishment), Bhojpur who shall examine the case of the
